Fair Work Act 2009 Released

The Fair Work Act 2009 (the Act) was released 20 April 2009. The Act will form the basis of the new national system of workplace relations, and will replace the existing Workplace Relations Act 1996. **Aspects of the Act will commence on 1st July 2009.**

CVIAQ is hosting an "New Industrial Relations Laws" information session to be held at the CVIAQ office on Tuesday the 23rd June 2009 from 5.30pm to 7.00pm. The session will be facilitated by Mr Andrew Walker, McInnes Wilson Lawyers, partner leading the employment law division.

From 1 July 2009, the following aspects of the Act will become law:

- Unfair dismissal exemptions for small business employers.
- Enterprise bargaining in the pursuit of an enterprise agreement.
- Expanded Union right of entry.
- A new authority called Fair Work Australia (FWA) will replace the Australian Industrial Relations Commission, Australian Fair Pay Commission and Workplace Authority.
- A new inspectorate, the Office of the Fair Work Ombudsman will be responsible for providing information on and enforcement of the new legislation.
